I, Juan de Pareja:
The Story of a Great Painter and the Slave He Helped Become an Artist
by Elizabeth Borton de Trevino

Engaging and easy to read, this story, published in 1965, is a work of biographical fiction based on the real lives of Diego Velazquez and Juan de Pareja, master and slave. The story is related in the voice of de Pareja who was inherited by Velazquez when they were both young men. At that time and place in history, Spain in the 1600s, slaves were not allowed to practice the arts although they could assist their masters in the studio. Through studying the techniques of his master, de Pareja secretly teaches himself to paint.

Velazquez, recognized as one of Spain's greatest painters, is now considered the precursor of realistic, as well as impressionistic, painting. De Pareja became an accomplished painter in his own right and a number of his paintings currently hang in several European museums.

Outstanding Elementary Art Educator

Nancy Barsic

During her childhood, Nancy Barsic was surrounded by an enchanting family of creative people making art. The youngest of five children, she was often taught arts and crafts by her older siblings, plus her father and mother created art in their everyday surroundings at home. Happily absorbing all this and working to inspire others, Nancy is now a full-time elementary art teacher. This Iowa Artist member certainly seems to have learned very well how to inspire, because she was named the 2012 Outstanding Elementary Art Educator by the Art Educators of Iowa.

Nancy grew up with a family full of artistic creativity in Golden Valley, Minnesota, which is near Minneapolis. Her father was a tool and die maker by trade who was always building and making things when at home. Her mother enjoyed creatively arranging and decorating around the house. Nancy remembers that once her father piled the entire family of seven into the car with as many shovels as he could find and drove out to a road-building site. The family proceeded to dig out the newly exposed vein of clay that her father had seen there. They then

returned home, spread the clay out on the dining room table and cheerfully made it into pots, sculptures or other interesting shapes. Nancy explains that her family often did creative group activities like that. After her father retired, he continued these interests and made many outdoor decorations and garden accessories.

In Golden Valley High School, Nancy's art teacher was a very strong, positive influence on her educational direction. Nancy was even picked to go to a week-long summer art camp at Iowa State Teachers College in Cedar Falls before her high school senior year. Her art teacher, Dave Baker, had graduated from ISTC and so was active in referring his students there. Nancy really enjoyed this art camp experience at ISTC and pursued art in college at the University of Minnesota, graduating with a degree in art education. In 1971 she became the first elementary art teacher in the Minneapolis public schools. It seems the teachers of that school district had been on strike, asking for more preparation time, as they were finding the library



and physical education time slots not enough time off to prepare for the core classes. More time was then found by scheduling in music and art classes. These had not been previously taught in Minneapolis elementary public schools, and Nancy was hired to be their first art teacher.

After marriage and a few more years teaching, Nancy's husband got a job at John Deere and she was happy that they were moving to the area where she had enjoyed summer art camp many years before. They moved to Hudson, Iowa, near Cedar Falls and near Iowa State Teachers College, which is now the University of Northern Iowa. Nancy explains that she took a 23-year maternity leave, and while raising their six children, she found lots of moments to insert art into their childhood. After her children were older, she also began accepting substitute art teacher jobs, finally settling permanently to teach elementary art in Cedar Falls.

Nancy has been fond of paper cutting since she was a little child. When she was four years old, her father saw her struggling with poorly made, rounded-tip child scissors so he took a pair of small but sharp adult embroidery scissors, rounded and smoothed the tips, and gave them to Nancy. This helped so much and paper cutting was now often included among her art activities as a child. Many years later, Marie Cook, who was a well-known Iowa Artist watercolor and cut-paper silhouette artist, helped Nancy shape her cuttings into exquisite works of art. Then in 2004 Nancy was awarded a Japan Fulbright Memorial Fund Scholarship for teachers to travel for three weeks with 200 other teachers to Japan where she had many fascinating experiences, including finding and learning from an 84-year old woman in an obscure little Japanese village restaurant who had been cutting elaborate paper artwork for years.

These days when she's not teaching, Nancy often works in her

basement at home on ceramics and sits upstairs in front of the TV cutting silhouettes. She relates that she will be sitting in the chair watching television, cutting, and letting the paper scraps fall all around her, then her husband will come by and vacuum them up. What a perfect partnership to give us many more of this Iowa Artist's fascinating creations.

Rules/Propectus for Regional & State Show

Eligibility

Current members of Iowa Artists who are age 18 or older qualify for maximum 3 entries each. Official entry form signed and submitted by artist entering the show in accordance with directions stated on entry form.

Acceptable Work

All work must be original in concept and created by the artist. Reference photos must be of the artist's own taking or used by permission of originator. No copyrighted material may be used as reference.

Artwork must have been done within the last two years and not previously shown in Iowa Artists Regional or State Shows. Maximum dimensions (including frame or display apparatus) are 4'x4' in either direction.

Unacceptable Work

Photos, computer-generated art, computer art slides, videos or motion pictures are not accepted. Artwork done in workshops or classes under an instructor is not accepted.

Mediums

2-Dimensional:

- Oil or water-based paints or any combination of these, on flat surface, framed, and wired ready to hang. (Watercolor on paper must include a mat.)
- Pencil, charcoal, pastel, ink, or any combination of these, on flat surface, matted, framed, and wired ready to hang.
- Diptych or triptychs must have frames joined together in some fashion, wired ready to hang, and can not exceed 4'x4' in entirety.
- Collage must be framed and wired ready to hang.
- Artwork on wrap-round mounts with finished sides can be unframed and wired ready to hang.

3-Dimensional:

A category of combined 3-dimensional entries will be considered for awards if the number of combined entries totals 5 or more pieces. One blue ribbon, one red ribbon, etc. may be awarded for every 10 pieces or fraction thereof.

- Jewelry – overall concept and major embellishment must be of the artist's own creation, of normal size, handmade from original idea.
- Fiber & Textile – baskets, mats, weaving, rugs, hangings, quilts and printed textiles employing and original design and imagination.

- Ceramic – pottery, figures, and objects produced on a potter's wheel or molded by hand, fired, and glazed.
- Sculpture – wood, stone, metal, paper mache, mixed material, of normal size, handmade from original idea.
- Glass – blown or stained glass of own design.

Submitted Work

All entrants are responsible for delivery and pick-up of their own work. If shipped, work must be suitably ready to hang or display. Works will be given all possible care in handling and storing, however, the exhibit committees and Iowa Artists cannot be responsible for loss or damage.

Entrants may not remove work before the show is over without permission from the show chairman. Written permission is required when transporting artwork that is the property of another artist.

Judging

Regional Show:

The judge will select one piece from each 10 exhibited in the regional show for a first, second and third place ribbon. The judge will also select a number of honorable mentions at his discretion. Only artwork awarded a first place blue ribbon at the regional level shall advance to the state show.

In the event that a piece of artwork has received a first place ribbon and is later found to be unqualified for an Iowa Artists show, that piece may advance to the state show but will not be considered for an award.

State Show:

The judge will select the 3 highest awards in the following order: one piece of artwork to receive Best of Show, one for the Richard Heggen Award, and one for the Doris Frandsen Award.

The judge will select one piece from each 10 exhibited and award a first, second and third place ribbon. Honorable mentions will be awarded at the judge's discretion. All first place winners will receive a monetary award in addition to the ribbon.

If included at regional and/or state show, a Peoples Choice ribbon may be awarded according to popular vote of show attendees.

The judge will give a critique of artwork receiving awards and be available to answer entrants' questions concerning their entries.

If you are not currently a member of Iowa Artists the registration form must be accompanied by a \$25 entry fee. Pre-show registered artwork will have priority for available space.
